2013 - CFCE LOVELAND Summer Camp Information

We are excited to announce our 2013 summer camp information. This year we have decided to offer the option of signing up for two or four weeks of camp. However, understand that priority scheduling will be given to students who sign up for more than two-week sessions due to the high cost of hiring our qualified conductors and staff.

All sessions will run Monday thru Friday from 9am – 2pm, with only one exception - there will be a class on Saturday, July 6th to make up for no class on the 4th of July. The tuition rates are listed on the following registration form. Please note that the hourly **tuition rate goes down** when you sign up for four weeks. We encourage all children to attend four weeks of camp, but understand that due to schedules and finances this may not work for everyone. For this reason, we decided to offer the two-week option this year. **All ages are welcome at the Loveland camps.**

Places are limited, so please sign up **ASAP**. If a camp session is canceled by CFCE due to lack of participation, your deposit will be refunded. This is the only circumstance for which a deposit refund will be given.
