## 2013 - CFCE DENVER Summer Camp Information

This year with our growing interest in the Denver Metro area we plan to hold Conductive Education (CE) summer camps in Denver. Due to a wide variety of ages in the Denver area, we will hold two age specific camps, one in June and one in July. Each camp will be tailored for a specific age group and parents of the older children have the option of attending 2 or 4 weeks of camp. To avoid overlap and to assist with scheduling staff, the 2 week sessions will need to be consecutive – either the first two weeks or the last two weeks of July. However, understand that priority scheduling will be given to students who sign up for more than two-week sessions due to high cost of hiring our qualified conductors and staff.

The first camp in June will be for children aged 2-7 years and will run Mon-Fri for three hours from 9am – 12pm (noon). The second camp in July will be for children aged 8 and up. These classes will also run Mon- Fri for 5 hours from 9am – 2pm. However, there is one exception - there will be class on Saturday July 6<sup>th</sup> to make up for no class being held on July 4<sup>th</sup>.

On the next page you will see a breakdown of our tuition prices. If you attend four weeks of camp this summer the hourly tuition rate decreases which will be cheaper for you. Remember this program is age specific so you must sign up for the correct weeks as shown on the schedule. Please have a look at the options on the form to see which camp your child will fit in and the schedule options. If you would like to sign up your child for one or more of the camps listed, please fill in the registration form and return to CFCE either by fax (970-461-3472) or mail to: CFCE, 483 N. Denver Ave, Loveland CO 80537 by **March 28, 2013**. **You must pay the non-refundable deposit per session no later than March 28, 2013 to secure your child's placement in the summer camp(s).** Your balance will be due on or before the first day of camp. Places are limited, so please sign up **ASAP**. If a camp session is canceled by CFCE due to lack of participation, your deposit will be refunded. This is the only circumstance for which a deposit refund will be given.
